These Terms of Use (“Terms”) govern your access to and use of the firehard.ca website, the FireHard Canada Wildfire Exposure Rating (WER) system, associated tools, documents, guides, and services (collectively, the “Services”) operated by [FireHard Canada Legal Entity Name] (“FireHard Canada,” “we,” “us,” or “our”). By accessing or using the Services, you agree to be bound by these Terms.

1.1 Acceptance of Terms

By accessing the Services, you represent that you are at least 18 years of age and have the legal capacity to enter into these Terms. If you are accessing the Services on behalf of an organisation, you represent that you have authority to bind that organisation to these Terms.

1.2 Description of Services

FireHard Canada provides educational information, technical guidance, and certification services related to residential wildfire hardening. The Services include but are not limited to: the WER system and its associated module guides, the FireHard Self-Assessment tool, FireHard certification through multiple pathways, the Insurer Partner Directory, and the FireHard Canada integration.

1.3 Informational Purpose Only

The information provided through the Services is for general educational and informational purposes only. It is not intended as, and shall not be construed as, professional engineering advice, architectural advice, building code compliance advice, insurance advice, legal advice, or a substitute for the services of qualified professionals.

1.4 No Guarantee of Wildfire Protection

Wildfire outcomes depend on numerous factors beyond the scope of building construction, including but not limited to: fire intensity and duration, wind speed and direction, ember density and transport distance, terrain and topography, suppression response timing and effectiveness, vegetation conditions, neighbouring property conditions, and other environmental variables. The WER system measures a property's resistance to specific wildfire exposure mechanisms; it does not predict wildfire outcomes.

This FireHard Compliance [Certificate/Report] documents the condition of the subject property against the FireHard Canada Wildfire Exposure Rating (WER) system specifications as of the assessment date stated above. It is issued subject to the following conditions:

- 1. No guarantee of survival:** This document does not guarantee, warrant, or represent that the subject property will survive a wildfire event. Wildfire outcomes depend on fire intensity, duration, wind conditions, ember density, suppression response, terrain, vegetation, neighbouring property conditions, and other factors beyond building construction. The WER rating measures resistance to specific wildfire exposure mechanisms; it does not predict outcomes.
- 2. Point-in-time assessment:** This document reflects the condition of the property at the time of assessment only. Subsequent modifications, deterioration, damage, changes in vegetation, or changes in neighbouring property conditions may alter the property's wildfire resistance. The property owner is responsible for maintaining the measures documented in this report.

NEXT STEPS FOR LEGAL COUNSEL

1. Review all clauses for compliance with BC and Alberta law (primary operating jurisdictions).
2. Confirm the limitation of liability cap (\$100 / 12-month fees) is appropriate and enforceable in each jurisdiction.
3. Review the indemnification clause (Section 5.5) for enforceability with consumer users (some provinces limit consumer indemnification).
4. Advise on whether a separate Privacy Policy document is required under PIPEDA and/or BC PIPA for the data collected through the certification process.
5. Advise on whether the P.Eng liability provisions in Pathway C require additional language or separate agreements.
6. Review the shutter interior label safety language for product liability implications.
7. Advise on insurance requirements for FireHard Canada and Wildernest Systems (errors and omissions, general liability).
8. Confirm that the California equivalency statement does not create exposure under US law.

Verification Pathways

The WER system recognizes three pathways to meet each specification. This mirrors how building codes work — a prescriptive path for straightforward compliance, and alternative solution paths for flexibility.

Deemed-to-Satisfy

Materials and assemblies explicitly named in the FireHard specification. If the design guide lists it, it meets the standard. Example: fibre cement panel, metal cladding, stucco, or masonry all satisfy “noncombustible cladding (or engineered equivalent)” without further testing.

Tested Equivalent

Products tested to the referenced standard by a recognized testing laboratory. The manufacturer's test report is the evidence of compliance. Example: an ember-resistant vent not listed in this guide but tested to ASTM E2886 by an accredited lab meets the WER-2 vent specification.

Engineered Alternative

A P.Eng. assessment demonstrating equivalent performance through analysis. The engineer's sealed report is the evidence. Example: a heavy-timber fence post (140×140mm minimum) may satisfy the WER-2 fencing specification through charring rate analysis, even though it is not noncombustible.

Fire-Rated Timber

Where a specification says “NC or fire-rated,” fire-rated timber is an acceptable alternative when it meets minimum section dimensions. Large-section timber chars at a predictable rate (approximately 0.65mm/min for softwood per Eurocode 5) and can maintain structural integrity for defined periods. For fencing, outbuilding framing, and deck substructure, timber sized to resist ignition for the design fire exposure period is acceptable at WER-1 through WER-3. Minimum section dimensions are specified in the relevant design guides. At WER-4, all exterior materials must be noncombustible — no timber alternatives.

Close Neighbour Exposure Level (CNEL)

Most Canadian subdivision homes are built 1.5–6 metres apart. If any face of your home is within 10 metres of a neighbouring structure, the CNEL system applies to that face. Measures scale with WER level. See the CNEL section in each FireHard design guide and Construction Detail Guide 6 for full technical details.
